Requirements for tables	The tables are made with font size 10pt Times New Roman. No breaks and runaround. All tables should have a title.
Requirements for drawings	Graphic material (graphs, charts, drawings, diagrams, logos, etc.) must be made using graphic editors: CorelDraw (not above v.12), Adobe Illustrator (not exceeding v. CS2), and saved in the formats *. cdr, * .ai, * .eps,
	respectively. Scanning of graphic material and its importing into the above editors is not allowed; illustrative material (photographs, collages, drawings, graphics, etc.) must be saved in * .tif, * .psd, * .jpg format (quality "8 - max") or * .eps (Adobe PhotoShop) with resolution at least 300 dpi, size no less than 115 mm in width, color model CMYK or Grayscale. Illustrative material
	should be submitted in the form of original photographs, negatives or slides, printed files. Graphic material, made in Excel do not require to be converted into other formats. Figures inserted in the text without runaround. Titles to figures should be in the text. Introducing titles into the body of the drawing, scanning and presenting it as a title is strictly prohibited.

	2008. Quoted sources are included into a common list at the end of the article in the order of their mention. The sequence number in the text is in square brackets. The text should contain references to all quoted sources.
